NOTICE OF DECISION

I refer to your request, under the Government Information (Public Access) Act 2009 (GIPA Act), to obtain information held by Game Council relating to:

- 1. Number of successful prosecutions of illegal hunting activity since the Game Council came into existence, including a log of type of infringement, corresponding penalty notices, location (National Park/ State forest/ Crown Land/ Private Property) and date of incident.
- 2. Number of infringements or penalty notices for offences issued per annum since the Game Council came into existence, including a log of type of infringement, penalty imposed for each offence, location (National Park/ State forest/ Crown Land/ Private Property) and date of incident.
- 3. Number of investigations conducted by the Game Council or an appointed inspector for the Game Council conducted into illegal hunting activity in National Parks and how many have resulted in penalties imposed or prosecution by the courts, including a log of the investigations, the outcome including any by the courts or Game Council, the location of the investigation and the time period of the investigation.
- 4. Number of allegations of breeches of the Game Council Code of Practice reported to Game Council per annum, including information on how any allegations of breeches have been proven.
 - a. Of those allegations proven, provide a log of details of the activity and the penalties imposed by council, and what type of entity lodged the complaint (public/ government agency)

Number of suspensions and/ or cancellations of Restricted (R) licences that Game Council implemented per annum, as provided under the Game and Feral Animal Control Act 2002 S29, since the inception of Game Council, including a log of suspensions and cancellations including the date, location, details of offence and the penalties imposed by council.
