SECTION 82(1) DETERMINATION NO. 747 OF 1982

Following agreement being reached with the Public Service Association of N.S.W. the Board has, pursuant to Section 82(1) of the Public Service Act, 1979, determined the salaries of Stores Officers as follows, subject to the conditions hereinafter indicated.

1. DEFINITIONS

"Officer" means and includes all persons permanently and temporarily employed under the Public Service Act, 1979, and classified in the General Division and who are appointed to positions classified under this Determination.

2. SALARIES

Subject to the provisions of the Public Service Act, 1979, and the Regulations thereunder, the following shall be the salaries to be paid to officers appointed to the positions specified.

An officer temporarily employed under the provisions of the Public Service Act, 1979, shall unless otherwise determined by the Board, be paid the weekly equivalent of the annual salary prescribed.

3. GENERAL

Except as specifically varied by this Determination the provision of Agreement No. 2038 of 1973 and Determination No. 534 of 1978 shall continue to remain in force.

4. WAGE BASIS

The salaries prescribed in Clause (2), Salaries, of this Determination are based on a basic wage of \$89.10 per week.

Such salaries shall be varied from time to time following any determination of the Industrial Commission of New South Wales made pursuant to Section 57 of the Industrial Arbitration Act, 1940, in like manner as if this Determination were an Award prescribing annual rates of salaries to which the provisions of that Act apply, provided that the salaries as so varied shall be adjusted to the nearest dollar.

5. DATE OF EFFECT

This Determination shall take effect on and from 2nd July, 1982.

It shall apply to all officers who, on the date of operation of this Determination, were occupying a position covered by this Determination, or who, after that date, are appointed to the position, but not apply to any person who resigned or whose services were terminated prior to the date of this Determination.
