Notice of Motion – Solidarity with Bankstown No Income Management Campaign

That Marrickville Council:

- 1. Congratulates the Public Service Association members at the Bankstown, Lakemba and Fairfield Community Service Centres for successful work bans against the implementation of Income Management.
- Recognises that due to the actions of workers, unions and a coalition of community organisations, including a number of community organisations which operate in the Marrickville Local Government Area, no referrals for Income Management have been made through Child Protection in the Bankstown LGA (and therefore in NSW) to date.
- 3. Recognises that these actions have played an important role in highlighting the punitive and discriminatory nature of Income Management policies, which dis-empower marginalised communities and redirect significant resources which should be used to offer genuine family and community support.
- 4. Commits to work with PSA members and local community organisations that stand opposed to Income Management and its expansion into the Marrickville Local Government Area.

Background

Income Management is a Federal Government policy which quarantines 50-70% of a person's Centrelink income (and 100% of any advance and any lump sum payments received), usually onto a 'BasicsCard'. This card can only be used to buy 'priority items' at Government-approved stores. The policy was originally introduced as part of the Northern Territory Intervention. It was extended in July 2012 by the current Federal Government through the "Stronger Futures" package of legislation.

Stronger Futures extended Income Management into five "trial sites" – Bankstown in NSW, Greater Shepparton in Victoria, Logan and Rockhampton in Queensland and Playford in South Australia. The trial is targeted to "disadvantaged and vulnerable Australians" (as defined by the Act) in order to "encourage socially responsible behaviour", with a broad range of agencies given the power to refer a person onto Involuntary Income Management.

Involuntary Income Management in Bankstown applies to "disadvantaged and vulnerable Australians". People can be referred by agencies, with a broadening of which agencies have the power to refer someone for income management. Reasons that a person can be referred onto income management is that they are no financially secure. Given that the amount of the dole is significantly below what is required for a person or family to live above the poverty line, this potentially captures all persons on substantial welfare benefits.

The policy was previously found to be racially discriminatory by the United Nations. Reports on the implementation on Income Management and the NT Intervention have found a decrease in school attendance, increase in suicide rates by Aboriginal youth and an increase in Aboriginal incarceration. The Federal Government has spent more than \$500 million on the system to date, which is the equivalent of about \$5000 per person per year.

The Public Service Association (PSA), who represent Child Protection workers, have voted to ban income management and have made no referrals to income management in the NSW trial site of Bankstown. Their campaign is supported by a coalition against the expansion of Income Management in Bankstown and other areas, which includes:
