Dear Minister,

Re: Transition of Roads and Maritime Services Registries to Service NSW

I am writing to you as the Minister responsible for Service NSW, regarding the transition of Roads and Maritime Services Registries to Service NSW. The issue specifically relates to those RMS Registries not yet nominated for conversion.

The PSA and Service NSW have agreed to a process where Registry employees have the first claim (via a process of merit selection) for positions at their current grade and location. This enables staff to transition into Service NSW offices, to continue the expected service delivery to the public of NSW.

The Government announced the closure of: Woy Woy, Padstow, Fairfield, Carrington, Five Dock, Maroubra Junction and Thornleigh RMS Registries on the 12 May 2015. This has caused concern for members that further closures will be forthcoming. This has the potential to place members at a considerable disadvantage in terms of the above outlined process, excess travel and potentially the loss of positions.

The PSA has sought this information in consultative forums from Service NSW with regard to the continued conversion of all of these outstanding RMS Registries, but they are unable to provide us with this information or those commitments.

The PSA is seeking to reassure its members and asks for a commitment from the Government that RMS Registries listed in (Attachment A) will be converted to Service NSW worksites and continue to provide service to these communities.
