### 25 thousand signatures cannot be ignored!

The NSW Government avoided discussing our 25,000 signature petition Parliament that was lodged in November 2014. The purpose of the petition was to raise awareness of the privatisation among ADHC's staff & clients as well as the broader NSW is appalling the community SO it chose Government ignore the to concerns of 25,000 NSW taxpayers.

At our rally of 13 November 2014, the petition was handed to the late MLC John Kaye by our General Secretary Anne Gardiner. It was then tabled in the Lower

House by the Member for Balmain, Jamie Parker.

PSA Assistant General Secretary Steve Turner, together with a PSA member and constituents in the Balmain electorate met with Jamie Parker to work on progressing this important issue.
