SECTION 63(1) DETERMINATION No. 912 OF 1996

1. INTRODUCTION

The Public Employment Office has determined, pursuant to Section 63(1) of the Public Sector Management Act 1988 the salaries prescribed herein.

2. DEFINITIONS

"Officer" means a person appointed under the Public Sector Management Act 1988 to positions classified and graded in accordance with this Determination.

"Temporary Employee" means a person employed under section 38 of the Public Sector Management Act 1988 on work classified and graded in accordance with this Determination.

3. SALARIES

Subject to the provisions of the Public Sector Management Act 1988 and the Regulation thereunder, the salaries to be paid to officers and temporary employees covered by this Determination are those specified in the schedule annexed hereto; provided that a person temporarily employed under the provisions of the Public Sector Management Act 1988, be paid at the weekly equivalent of the annual salary prescribed.

4. PAY MOVEMENTS

Progression within the grades and classifications, where appropriate, will be incremental (12 months) subject to satisfactory conduct and service.

Promotion will be subject to a vacancy and appointment on merit.

5. DATE OF EFFECT

This determination shall take effect on and from 24 December 1996.
