Further these risks needs to have clear stewardship by a member of the executive. Urgent treatment is required to reduce the level of risk, with ongoing active review of treatment options and supporting plans.

 Critical Control
 The inherent level of risk is high however there are strong controls in place to support the mitigation. Consequently there is a high reliance on the operating effectiveness of these controls to minimise the likelihood or impact should the risk event occur. Controls need to be constantly monitored by senior members of the leadership team to confirm their effectiveness (i.e. at least quarterly)

 Periodic Review
 While the controls are not always strong, the inherent risk rating is not the table blevels either. Management should consider options to improve the control environment through appropriate risk treatments, or monitor the risk profile to ensure it does not increase over time.

 Risks where systems and processes managing the risk are adequate. Monitoring of the controls and the risk profile should occur periodically.
