


Q1 What is your Role?



Q2 How many years have you been employed in DCJ?




Q3 Which District do you work in?


Q5 Are you a PSA member?

Q6 Have you completed the Positive Behaviour Support training?





Q7 Do you feel sufficiently qualified and confident to develop, write and implement a Behaviour Support Plan (BSP)?





Q9 Do you feel sufficiently qualified to give ongoing support to the child and relevant adults e.g. carer?





Q10 What are some of the challenges you face in developing and implementing BSP's?(please tick all that apply)





Q11 How effective/helpful do you feel Behaviour Support Plans written by Caseworkers are to the child and carer?





Q13 On average, how many hours do you spend on developing, writing and implementing a new Behaviour Support Plan?





Q14 On average, how many hours do you spend completing reviews of Behaviour Support Plans?





Q15 Are you familiar with the department's policy and procedure on BSP's?





Q16 Do you find the department's policy and procedure on BSP's is simple and easy to understand?




