# 6. Reports

# 6.1 PSA CPSU NSW Executive Update – Troy Wright, Assistant General Secretary

Troy's briefing addressed the following:

- Recent pay deal for public servants three-year agreement at 4%, 3%, 3% with a buffer for inflation and cost of living increases.
- Pay deals for other public sector workers discussed e.g. teachers and police, including the details of the police agreement which need more contextual information over and above what has been reported in the media.
- PSA membership has grown 41,000 members
- There has also been a salary increase and settlement with groups in the public sector who had unjust and outdated conditions – special constables, sheriffs and grooms (working for NSW Police).
- Working on agreements in fisheries and for child protection workers.
- Significant problems with recruitment and retention of child protection workers current grading is 3-7 which is too low a starting point and needs to change.
- Out of Home Care is in crisis privatisation a total failure.
- Junee Correctional Centre comes under the public sector on 1 April 2025
- Slowly rebuilding capacity in the public sector.
- Current issues around WFH and delegate's rights.
- Government has set up a group to look at possible changes to the Government Sector Employment Act.

Troy thanked Retired Associates for the continuing commitment to the PSA. We wished each other a happy Christmas.

We noted the outstanding action from the October meeting in relation to asking Nathan Bradshaw to give an update about Icare and other current issues in his team.

Action: Carmel McKeough to ask Nathan Bradshaw to attend the February 2025 meeting and give a briefing about Icare and other current issues.

# 6.2 Combined Pensioners and Superannuants Association (CPSA)

Carmel McKeough gave a report of the CPSA Annual General Meeting held on 29-30 October 2024. The conference was opened by the Hon. Jodie Harrison, Minister for Seniors (by video). Guest speakers included Melanie Lennon from the Seniors Rights Service, Andy Schmulow who discussed bank closures and Nathan Aulsebrook who discussed dental care for older people.

Policy motions discussed and voted on included:

- Loss of banking services, cheques and ability to use cash;
- Digital inclusion;
- Community transport;
- Access to transport in rural, regional and outer urban areas;
- Older driver testing;
- Energy, including solar and cost of utility bills;
- Housing lack of supply, affordability and rental protections;
- Health care:
- Palliative care:
- Income security;
- · Aged care; and
- Disability support for people over 65.

CPSA held its final executive meeting for the year on 27 November 2024. Current deliberations with DCJ were discussed.

# 6.3 Quality Aged Care Action Group (QACAG) Meeting

Dave McKeough attended a meeting on xx 2024. Issues discussed included the new Aged Care Act and the preparation of a submission opposing the cessation of funding for a mobile x-ray service on the central coast.

There was also discussion about the circumstances surrounding the death of Clare Nowland.

### 6.4 Sydney Retired Unionists Group (SRUG)

Barry Blanchard advised that SRUG met on 4 November 2011 at the headquarters of the Teachers Federation. Maxine Sharkey, General Secretary of the Federation was the guest speaker.

Councillor Slyvie Ellsmore (Greens) from the City of Sydney will be the guest speaker on 10 February 2025 and will be discussing housing.

SRUG is looking to have a place to practice singing as there is always a union song at the end of meetings.

The NSW Seniors Festival will be held from 3-16 March 2025. There will be a Seniors Expo on 12-13 March at Darling Harbour.
